On 09/17/2001, six days after the terrorist events of 09/11/2001, SAs [redacted] and [redacted] interviewed [redacted] 100 Manhattan Avenue, [redacted] Union City, New Jersey. [redacted] had previously telephoned the Newark FBI and indicated that he had photographs prior to the explosions at the World Trade Center.

The above-referenced agents retrieved the photographs from [redacted] at his residence, however, upon review, the photos appeared to be taken around the time of the collapse of the first tower, not prior to the attack.

While in the apartment building, the interviewing agents were advised by security to speak to another tenant who might have knowledge of the event. Neither agent is able to recall the name of the woman at present.

The interviewing agents spoke with the referenced woman who provided no additional information. After determining that the woman could provide no relevant information, the agents thanked her for her time and proceeded to leave. The woman accompanied the agents to the elevator on her floor.

While waiting for the elevator, the agents noticed a drawing, approximately eye level, on the wall near the elevator call buttons. The drawing appeared to depict the World Trade Center towers. This was evident by the shape of the buildings depicted, with one tower bearing a large antenna at the top. There was no evidence indicating how long the drawing had been there.

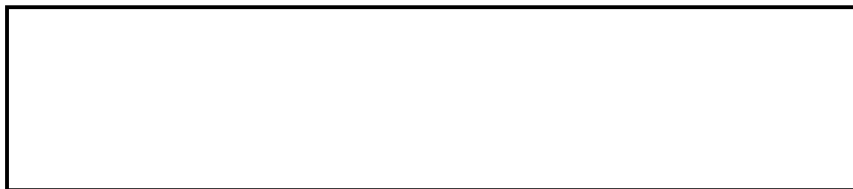
